## **New Business:**

To discuss Zoning Resolution Article 100-8.4, per the request of the Swancreek Water District. Chairman Walt Lange asked Swancreek Township Zoning Inspector Walt Hallett to clarify the differences between Swancreek Township Zoning Regulation and Swancreek Water District Regulations pertaining to zoning resolution article 100-8.4. Members from the Swancreek Water District board during the public forum said that the current verbiage in the Swancreek zoning regulations does not match the verbiage from the Swancreek water district and the Fulton County Health Department causing confusion for Swancreek residents on which regulation to follow. Sally Wylie read Ohio Revised Code (ORC) 6119.06 Z pertaining to public water and asked for clarification from the present water board members.

Demolition Permit fee was discussed. Chairman Walt Lange researched prior to the meeting demolition permits from neighboring areas and suggested based on the sampling of demolition permits that this may be a building code issue verses a zoning code issue. Joe Kahl discussed the demolition permit may be used for blight issues. Swancreek Township Zoning Inspector Walt Hallett explained to the board how he currently handles demolition needs and residents could use the zoning permit application for demolition purposes. Chairman Walt Lange suggested that further investigation is needed before further discussion can proceed.
