"Prior to issuing a zoning permit for a residential structure, the following permits shall be obtained: Septic Permit, Water Permit public water, well water or pond utilized for drinking water and Drive permit"

with article 100-18.2 paragraph i. on Page 78 of the Swancreek Zoning Resolution

"Prior to issuing a zoning permit for a residential/commercial structure, the following permits shall be obtained: Septic Permit, Water Permit, public water shall be utilized if available, if public water is not available; well water or a pond utilized for drinking water and a Drive Permit".

Discussion was had regarding the different districts and the effects of the Zoning Resolution. Lennox Mitchell suggested possibly adding a New Construction definition to Article 100-23. Joe Kahl would like to review how the Fulton County Zoning Regulations were written pertaining to the utilization of public water.

Walt Lange suggested that we not to go forward with the proposed amendment at this time until further research is done. Sally Wylie suggested involving Walt Hallett Zoning Inspector for Swancreek Township in this process. The Zoning Commission also discussed requirements and regulations for structures.
