SPECIAL GUEST: Deputy Sheriff Galbraith presented Swancreek Township activity report from December 16, 2019 to February 3, 2020. The Fulton County Sheriff's Department had received 105 calls. One theft was reported and all the others were traffic stops and crashes. Len Mitchell from the audience asked about truck traffic on County Road D- Deputy Sheriff Galbraith states they are aware of it and working on it. He also stated that County Road D and County Road 3 is where the most crashes happen in Swancreek Township. The Board thanked him for the information.

Maintenance Supervisor Updates:

Rust/Maintenance of Chevy Pickup- Trustee Kazmierczak states the estimate from Sampsel's is \$5,000.00. The Board would like a second estimate.

6767 Co. Rd. 2 Catch Basin- Keller Property- Trustee Kazmierczak informed resident Joe Keller in the audience that the Township obtained permission from Mr. Keller's neighbors to have the County Surveyor and County Engineer's office shoot elevations on their property. Discussion was had with Mr. Keller and the Board on what the Township was proposing to do to correct the drainage problem. Mr. Keller asked the Board when they thought the County would be able to shoot the elevations. Trustee Kazmierczak told Mr. Keller it would probably take a couple of weeks for this to happen.

Zoning:

Ostafi property 1671 Co. Rd. D- Zoning Inspector Pallitta gave an update. She has met with the owner at the property and it went well. Zoning Inspector Pallitta will continue to work with Ms. Ostafi on the blight issue at the property.

Zoning Inspector Pallitta gave a complete report on all activities she has had since the last meeting. She also informed the Board that she has been in contact with the company that looks at properties for cell towers and she has asked them to come and look at the Township for possible location. She informed the Board that the Board of Zoning Appeals will have a hearing February 20th.

Permissive License Tax- Discussion was had about both of the taxes with the Board answering questions from the audience.

Trustee Weigel went on record stating that the Township just passed a much needed Fire Levy and while he is in favor of passing ORC 4504.18 he feels that the Township is in good financial standing and does not need ORC 4504.181 at this time. Trustee Weigel asked that the votes be taken separately for each tax.

045-20 Trustee Wilson motioned to enact ORC 4504.18 Supplemental Township License Tax for the purpose of paying the costs and expenses for construction, reconstruction, improvement, maintenance, and repair of Swancreek Township's roads, bridges, and culverts, for purchasing, erecting, and maintaining traffic signs, markers, lights, and signals, for purchasing road machinery and equipment, and planning, constructing, and maintaining suitable buildings to house such equipment. The tax shall be at the rate of five dollars per motor vehicle on all motor vehicles the owners of which reside in the unincorporated area of the township and shall be in addition to the taxes at the rates specified in sections 4503.04 and 4503.16 of the Revised Code, subject to the reductions on the manner provided in section 4503.11 of the Revised Code and the exemptions provided in sections 4503.16, 4503.17, 4503.171,4503.41 and 4503.43 of the Revised Code, 2nd by Weigel.

046-20 Trustee Wilson motioned to enact ORC 4504.181 Permissive Tax Levy for Operation of Motor Vehicles in unincorporated territory of Swancreek Township for any authorized purpose. The tax shall be at the rate of five dollars per motor vehicle on all motor vehicles. The rate of tax is in addition to the tax rates prescribed in sections 4503.04 and 4503.042 of the Revised Code, 2nd by Trustee Kazmierczak.
