Zoning:

Zoning Inspector Wylie reported on the two properties that she has been working with to clean up the blight. County Road D was to have an action but due to the weather, has not been able to hold it. The landowner (Ostafi) has been in contact with Zoning Inspector Wylie. Also due to the weather, Zoning Inspector Wylie has not sent out the letter to the landowner (Kobeck) on County Road 3.

Public Forum:

Resident Dan Gillen 3911 County Road D asked Zoning Inspector about an existing garage that the home owner rebuilt. Mr. Gillen is claiming that it was built on an existing leach field. Zoning Inspector Wylie will contact the Fulton County Health Department to look into this.

Liz Victor 1045 County Road B asked the Board what the Township's expense was on the Meyer case, and asked about the Vac truck that the Township sold back to the company-what was the loss and what did that mean for the Township. Trustee Kazmierczak told her he didn't have the actual dollar amount and that we had insurance that covered a portion of it. He also explained that the Township took a \$40,000.00 loss on the Vac truck and the money came from the American Relief Plan. So while it was tax payers money- it wasn't specifically from Swancreek Township, it was Federal Tax money.

Andrew Frost 1709 County Road EF asked if the Township would be willing to sell the parcel of Homewood Park that they own to him. It butts up to his property. The Board informed him there was a Resolution on file to not sell any of Homewood Park for a period of time. Fiscal Officer Stultz will find the Resolution and get the information back to him.

Trustee Kazmierczak explained the recommendation of Jacob Barnes to ban it until the Township had a plan on where they wanted it located and the number of facilities they wanted. The Township has Zoning Commission representatives going to OTA and they will be attending the course on Issue 2.

Cemetery Fee Discussion- It was brought to the Board's attention that Swancreek Township is charging only \$500.00 for resident graves. The cost of concrete is \$400.00. Trustee Kazmierczak asked Office Manager Wheatley to look up the last Resolution on grave prices.
